

UJAM Trademark Use Guidelines and Policy

This UJAM Trademark Use Guidelines and Policy (the "Trademark Guidelines") outlines the guidelines and policy for the use of trademarks, whether registered or unregistered, owned by UJAM Music Technology GmbH ("UJAM") and third-party trademarks on UJAM's website. The purpose of these guidelines is to ensure that trademarks, service marks, trade names, logos, product names, and other brand features, whether registered or unregistered, (collectively, "Trademarks") are used in a manner that protects their value and complies with legal requirements.

1. Permitted Uses of UJAM Trademarks

- 1.1. You may use UJAM's Trademarks to reference UJAM's products, services, and promotions, provided you follow these Trademark Guidelines and comply with any agreements you may have with UJAM.
- 1.2. You do not require UJAM's express permission when using UJAM's Trademarks to refer to UJAM products or services; provided that the references are truthful, fair, do not violate Section 2 ("Prohibited Uses") of these Trademark Guidelines or suggest UJAM's sponsorship, affiliation, or endorsement of your products or services. Unless otherwise permitted by applicable law, any other use of UJAM's Trademarks requires UJAM's prior express written permission.
- 1.3. When using UJAM's Trademarks, proper attribution of trademark ownership should be included and displayed as follows on/in the page, content, media, or materials which display or otherwise refer to UJAM's Trademarks:

"UJAM, [list additional UJAM Trademarks], are trademarks owned by UJAM Music Technology GmbH."

1.4. UJAM's Trademarks may not be used in any manner as described below under Section 2 ("Prohibited Use").

2. Prohibited Uses

- 2.1. In no event may UJAM's Trademarks be used in a manner that is misleading, confusing, untruthful, unlawful, defamatory, obscene, racist, sexist, or in connection with any illegal activities.
- 2.2. Unless permitted under applicable law, UJAM's or third-party Trademarks may not be altered, modified, or changed in any way.
- 2.3. Any use of the UJAM Trademarks shall be prohibited, with the exception of the permitted uses specified above under Section 1 ("Permitted Uses of UJAM's Trademarks") or as permitted by applicable law.



3. Use of Third-Party Trademarks

- 3.1. UJAM's website may include third-party Trademarks. These Trademarks are the property of their respective owners, and their presence on UJAM's website does not indicate any affiliation with or endorsement by their owners.
- 3.2. Third-party Trademarks found on UJAM's website may not be used without the permission of the respective trademark owners, unless otherwise permitted by applicable law. Such use shall also comply with any guidelines or restrictions set by the trademark owner, as applicable.
- 4. Reporting Unauthorized Use: If you become aware of any use of UJAM's Trademarks or any third-party Trademarks that violates these Trademark Guidelines, please report this to UJAM immediately by contacting legal (at) ujam . com.
- 5. Modifications to these Trademark Guidelines: UJAM reserves the right to modify these Trademark Guidelines at any time without notice. Users of UJAM's Trademarks are encouraged to review these Trademark Guidelines periodically for any changes.
